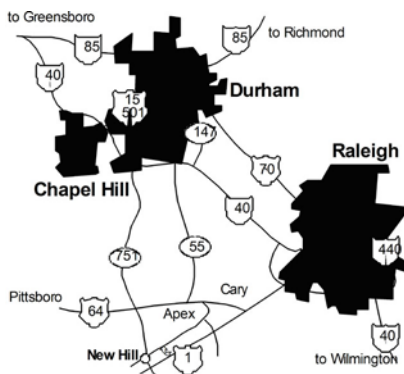


**Directions:**

New Hill is just south of the Triangle Area of North Carolina, and is less than an hour's drive from Chapel Hill, Durham or Raleigh. Autumn Winds Agility Center is on Bosco Road, the second right on Old US 1, going north from New Hill towards Apex. There will be dog show signs on the day of the trial.

**From Chapel Hill or Durham** - Take state Hwy 751 or 55:

- Go south on 751. Go straight at the Hwy 64 intersection. Continue on New Hill-Olive Chapel Road until you reach the stop sign at New Hill. At New Hill, turn left onto Old US 1 toward Apex. Look for Bosco Road on your right.
- Go south on 55, toward Apex. After passing the US Post Office in Apex, turn right at the first light onto Salem Street (which becomes old US 1) towards New Hill. Look for Bosco Road on your left, just before you get to New Hill.



**From Raleigh:**

- Go south on US 1, to the New Hill exit. Turn right at stop sign. The next stop sign is at New Hill. Turn right onto Old US 1, toward Apex. Look for Bosco Road on your right.

On Saturday, March 16 and Sunday, March 17, 2013, AUTUMN WINDS AGILITY CLUB will host two agility trials, per day, under the regulations of the United Kennel Club, Inc (2013 Official Rules). This off-lead trial is open to all UKC registered dogs that are twelve months of age or older. Agility I, II, and III titling classes will be offered. Entry in the Agility II class is open to dogs with or without the Agility I title. A dog may be entered in the Agility I and Agility II classes at the same trial. Entry in the Agility III Class is open only to those dogs that have completed the requirements for the Agility Champion title (UACH). Only dogs with a UACHX title are eligible to compete for the UGRACH title. Course familiarization for handlers will begin at 7:30 am. Trial I will begin promptly at 8:00 am. Course familiarization with dogs will be on lead at the beginning of each height division for AGI-A and AGII-A.

**Trial 1 will begin at 8:00 am; Trial 2 will immediately follow Trial 1 for each class category. Trials will be run AGI, AGIII and AGII. Trial 1, AGI will be followed by Trial 2, AGI, and continue with each class. This will be the running order on both days.**

Equipment will be provided courtesy of the Autumn Winds Agility Center. The trials will be held outdoors on a grass surface, rain or shine. All dogs must be on lead or crated except when exhibiting in the ring. Bring chairs, water, and shade. A food vendor will be on site.

***To Register:***

To register, fill out the enclosed entry form (or a copy). Entries close at 6:00 PM on March 9, 2013 or when the event limit (200 runs per day) is reached.

Entry fees are \$18 for the first entry and \$15 for the second (or third) entry of the SAME dog in the SAME trial. For example if:

Spot is entered in AGI & AGII, Trial 1 – Cost \$18 + \$15 = \$33.

Spot entered in AGI, AGII & AGIII Trial 1 – Cost \$18+\$15+\$15 = \$48

But if Spot is entered in AGI, Trial 1 and Trial 2 – Cost \$18+ \$18 = \$36  
(one dog in two different trials)

Also, be sure to indicate if your dog is in section A or B (AGI-B, AGII-A, etc.). “A” is for dogs who have not yet attained a title in that class; “B” is for dogs working towards their UACH or higher. Handlers, trainers, and judges must show in section B, but if their dog has not attained a title, they may also participate in the course familiarization with their dog. There are no A or B divisions in AGIII. **If you will be running your dog as a “Veteran” (dog must be 7 years old), please mark this on your entry form as well.**

**Awards:**

Rosettes and prizes will be awarded for High in Trial, High Combined and High Triple. Placement ribbons and prizes will be awarded to the first through fourth place qualifying dogs in each class in each trial. All qualifying scores will receive qualifying ribbons. Specialty prizes may also be awarded.

**Notice to Exhibitors:**

- The safety of the dogs is of primary importance. By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are familiar with and able to perform all of the obstacles safely.
- Choke collars, pinch collars, electric and dummy electric collars are prohibited.
- Food and toys are not permitted in the course area. Handlers are not permitted to use whistles or other instruments or devices.
- It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dog and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the trial judge, be asked to leave the show site. In such case, no refund of any fees will be made.
- Please be considerate of others and clean up after your dog at the trial site and motel facilities.
- Entry fees shall not be refunded in the event that the dog is absent, disqualified or excused by Veterinarian or Judge. Refunds will be provided for persons withdrawing before March 9, 2013. Autumn Winds Agility Center will retain a \$5.00 handling fee for processing the early withdrawal. If because of riots, civil disturbances or acts beyond control of the management it is impossible to operate or complete the show, no refund of entry fee will be made.
- Judge will not wait for any dog holding up the judging of a class.
- Incorrect/incomplete entries, late entries or entries received without the appropriate fees will not be accepted. They will be returned to the sender via U.S. mail. (Minor questions may be handled by e-mail or telephone.)
- Bitches in season will not be allowed on the premises Saturday, March 16 or Sunday, March 17, 2013.
